Rules 2018

The Group of Ten Photography Club is hosting its 11th Amateur Photo Competition and Show Tuesday April 25 to Sunday May 7, 2017 at the Shurniak Art Gallery in Assiniboia, Saskatchewan. There are eight categories; 1st, 2nd, 3rd, honourable mention and prize amounts of \$100, \$75, \$50.

Black and white or color may be entered in any of the following categories:

All entries must be submitted by email to the Group of Ten Website by 9:00 PM, Saturday, April 1st.

Late entries will not be accepted.

Contest Rules:

The following rules govern the competition. All entrants are assumed to have read and understood these rules and have agreed to abide by them.

1. The Group of Ten Photography competition is open to all amateur photographers. An amateur photographer is someone making less than 50% of their income from the sales of photographic services.
2. There is no limit to number of entries - but must not have been entered in this competition before. No photo can be entered in more than one category.
3. You must add **Photo Submission** to the subject field of your email. Send your show submissions and entry form using the free file transfer service <https://www.dropbox.com/> on our web site groupoftenphotographyclub@yahoo.ca
4. The file name of your image must be **your name, competition category and the title of your picture** e.g. Bob Jones - Passageways - Bridge.jpg.
5. Images must be in jpeg format and preferably no larger than 1000 pixels in width or height. Images should be unframed. All photo editing/parts of the photo must be the work of the photographer submitting the picture. No identifying marks on images submitted.
6. The competition is aimed at the digital photographer, rather than digital artist or graphic designer and while post capture processing is expected in the case of RAW files, excessive, unnecessary or unrealistic photo editing of an image must be limited.
7. Photos will be judged in the category in which they have been entered.
8. All accepted entries will be judged. Entries not meeting all the rules will not be judged. The committee reserves the right to reject any entry. Photos deemed inappropriate for family viewing will not be displayed. The decision of the judges and the rules of the Group of Ten Photography Club are final.
9. Entrants 18 years of age or younger may submit photos in the Youth category but are not restricted to that category.
10. Entrants will allow the Group of Ten Photography Club to display winning entries for promotional purposes.
11. Competition winners will be contacted and asked to provide a full resolution jpg copy of their image. Cropped images must fit 11" X 14" (4200 X 3300. Resolution 300 dpi) for printing.

Receipt of a submission will be acknowledged by e-mail as soon as payment is received.
